## Michele Young Biography

Michele Young is a graduate of Georgetown University Law Center, a former adjunct law professor in two law schools and law clerk to three federal judges, including the Hon. George Edwards, Jr. of the U.S. Court of Appeals of the Sixth Circuit, author of articles and co-author of a law book for the American Bar Association. Ms. Young considers it an honor and pleasure to redress each and every injustice and to serve the legal needs of each individual in need of help. Her lawyering is distinguished by an emphasis on innovativeness, integrity, non-stop hard work, and heart. She takes great pride in solving what appears to be, at first blush, an unsolvable legal problem. She has spearheaded successful political, public interest, civic, and media campaigns, serving as an advocate in whatever capacity is needed.

Ms. Young's present emphasis is to create a culture where everyone has a seat at the table. As a lawyer, she fights for the rights of Americans who are not treated fairly or justly by our government. Ms. Young is honored to represent Sherry Chen who was set apart and marked for a false arrest and malicious prosecution after a government worker sent an e-mail alleging an "American citizen but Chinese national," a security risk. Ms. Young is proud to represent the father and be part of the civil team trying to bring justice to the family of Gabriel Teye, the 8- year old who committed suicide after being brutally bullied. Michele helped and is a mentor to Tyra Patterson, free Christmas Day 2018 for a crime she did not commit after 23 years in prison.

Ms. Young's conviction to social justice goes deeper than her legal work; whether it is arranging for a single mother to have a new heater in her home or bringing holiday presents to an underprivileged child., she does what she can. Ms. Young is presently the Advisory Chair for the Ohio Asian Pacific Islanders American Public Affairs Association (APAPA), a board member of the Ohio Justice Policy Center, the American Jewish Committee, and a member of the Cincinnatius Association, Trialogue, and the Potter Stewart Inn of Court. She is part of the team of Interfaith leaders that founded Kids4Peace, the first summer camp where local Muslim, Christian and Jewish Kids come together. She prides herself on bringing leaders from all walks of life to come together to make difference whether it is in the life of a child or a community.

Ms. Young has led the "don't text and drive" campaign for Gregory S. Young Co. LPA. The six-year old campaign reaches hundreds of thousands of homes weekly, through television, features Cincinnati's icons and has been carried for years in partnership with CBS Local 12, CW, and Star 64 and now reaches high school students through anti-texting rallies. Ms. Young asked the first Asian-American woman to seek county office and ran her campaign without compensation to break through an age-old barrier. After the landslide victory, Michele received the received the 2014 Cincinnati Women Political Caucus Woman of Outstanding Achievement Award. In 2016, Michele was the endorsed Democratic candidate for Congress for OH-1.
